3. Supervision Activities of BOD for the General Director:

3.1. Regarding production and business operations:

In 2025, the Company's core production business remained temporarily suspended, The Company primarily focused on asset preservation, liquidation of unused machinery, equipment and tools. The General Director implemented solutions appropriate to the actual situation to execute the 2025 business plan in accordance with the Resolution of the 2025 Annual General Meeting of Shareholders and the strategic orientation of the Board of Directors, in compliance with the provisions of law, the Company's Charter and Regulations:

- Continue to reduce costs
- Enhanced asset preservation and liquidation of unused machinery and equipment. In 2025, the Company liquidated machinery, equipment and tools, generating proceeds of VND 1,862,592,593 (Excluding VAT) - Accounting for 0.5% of the Company's total asset value (VND 370,945,089,579) according to the audited separate financial statements as of June 30, 2025.
- Seeking partners to utilize existing premises.
- Seeking partners to sell unused assets.
- Promote the partner to deliver the fabric cabinet inventory. However, 160,660 inventory products have not yet been delivered (the processing cost of the inventory and the amount unpaid by customers is VND 121,907,164,547).
- Retail pharmaceutical business at the Pharmacy located at 213 Hong Bang.
- Monitor and urge Phu My Corporation regarding the Phu My Housing Project to sell products and recover capital contribution (Phu My Corporation has completed infrastructure construction and offered terraced houses for sale).
- Ensure stable income and effectively implement policies and benefits for employees.

3.2. **Investment in 2025:** In 2025, the Company contributed an additional VND 1,056,820,000 to Phu My Corporation, increasing the contributed capital from VND 23,914,030,000 to VND 24,970,850, accounting for 27.39% of the charter capital of Phu My Corporation.

3.3. Regarding financial management:

- In 2025, the Company's core business production remained temporarily suspended due to no orders. The Company's main revenue generated from business cooperation profit and pharmaceutical retail activities.
- Ensured timely information, reporting and settlement is in accordance with regulations.

- Directed and supervised cost management and savings in operations.
- Supervise the distribution of 2024 profits according to the Resolution of the 2025 Annual General Meeting of Shareholders.

3.4. Regarding the organizational structure: The Board of Directors supervised the Company's organizational structure to minimize costs for the Company.

- Reduce labor to minimize losses. As of December 31, 2025, the Company had 28 employees (Including the Parent Company and subsidiaries), a reduction of 01 employee compared to the end of 2024.
- Review regulations and operating costs to maximize cost savings for the Company.

4. Activities of the subcommittees under the Board of Directors:

The Board of Directors has not yet established any Subcommittees. Currently, the Board of Directors operates based on members jointly discussing and deciding on strategic development direction, investment, human resources and remuneration for the Board of management and management officers to implement.
